#### **Presentations:**

### Linda Stetson-Library Director Nina Taylor-Teen Librarian

- · Spoke about the good work for youth and positive attendance by youth using the library
- Interest in increasing Nina's hours to continue to serve youth including many hard to reach or at risk youth. Many reasons were identified including the ability to provide support to preparing youth in preparing for the future, the ability to collaborate with community organizations, less police involvement due to structure offered, great connections with kids

#### Tim Collins, Athletic Director Natick Middle and High Schools

- Reviewed the process for supporting athletes and in particular those identified with a substance abuse problem
- Longer discussion about how athletes who using drugs and alcohol are identified anonymously to school administration through pictures on Facebook etc. during out of school time. Some communities use an "in the presence of" rule which means if an athlete is at a place where illegal substance are, they can be held to MIAA standards. Natick does not use this rule.

- Shelley Joseph, Attorney and Natick resident who represents youth and adults mentioned that communities have different standards. Talked how the legal process works.
- Shelley and Erica will create a document that outlines how the legal system works when a student athlete is caught
- Zach Galvin is looking into what can be done when he receives tips and pictures etc.
- Tim is planning to host two meetings a year to talk with parents of student athletes
- An NTY member sent an email asking that the messages be delivered in a clearer and stronger fashion during parent/athlete meetings

#### Robert Rosen, Natick Patch

- Will provide instructions and support to Erica

### Medicinal Marijuana Updates:

- 1. The law has gone into effect and DPH has 120 days to write the regulations that will in part determine how much is a 60 day supply. No licenses will be issued until the regulations are provided to communities.
- 2. There is a new movement to create a "third way" project on marijuana that is an alternative between legalization and the current status of marijuana. After many months of work on a national level, this third alternative has evolved into **Project SAM Smart Approaches to Marijuana**. SAM will be a bipartisan group, chaired by Rep. Patrick J. Kennedy, Jr., and will include George W. Bush's former speechwriter and Newsweek/Daily Beast columnist David Forum, Harvard Professor Sharon Levy, and other public health professionals and lawmaker.
